MPE cannot guarantee exhibitors against loss or damage of any kind. Space is purchased with the understanding that the exhibitors will hold the Exhibitor Coordinator, MPE or KCI Expo Center harmless from any or all liabilities from any cause. The Exhibitor Coordinator, MPE, or KCI Expo Center shall not be responsible for any loss, damage, or injury that may occur to the exhibitors, their employees, or property from any cause whatsoever prior to, during, or subsequent to the period covered by the *Exhibitor Application Form and Contract*.
